All of those responding to this survey (56 people) provided their names. There is no way of ensuring that these respondents were actually who they said they were!


#### 2. What is your Superkart Club?

Two thirds of the respondents had competed at an AS Championship at least once during the period 2008-12.



# 4. How many rounds (2 rounds held each year) have you competed in, during that time?




The majority (84%) of these respondents felt that the AS Championship events were relevant to them.


### 8. Why is the Cams Australian Superkart Championship not relevant to you?


While the majority (62.5%) felt that the events had met their expectations, just over a quarter (27%) disagreed and another 11% did not know (or were unable to provide an opinion).

The 35 people who found the events to meet their expectations indicated that the main reasons were "I enjoy race events with other Cams categories racing" and "Shannons series rounds are well organised".



















Just over a third of all respondents (19) indicated that their maximum affordable level is \$400/\$100. A further 18 respondents responded with \$450/\$150 whilst 12 suggested \$300/\$50 was more affordable.

It has become too expensive for the mid to rear of field guys to compete at a national level. Unless the costs reduce there will only be 5 in each class and no nationals. I believe we need to go backwards before we can forwards and if that means go back to the clubs for a few years well so be it.

Garaging is too cramped for the money we pay television options are worth paying for I don't want to run with Shannon series anymore

I do not think that Superkarting in Australia is a stepping-stone to the higher levels of Motorsport and as such, it should be treated for what it is: an enthusiast sport. Therefore, I believe that the Australian Superkart Championship should be run by the Clubs so that costs are keeping to a minimum and attendance is encouraged to its many members. To further encourage more people to attend the Australian Superkart Championship, I would reduce it to one event per year. I also see that the division between gearbox and non-gearbox Championships as a negative move for the Sport which belongs equally to all Superkarters, therefore it should include non-gearbox karts and gearbox karts in the one event. If this all sounds familiar, then you only have to look back a few years to see these how it used to be done and they number of members who attended those events.

SKA have completely missed the issue with low entry numbers. The idea of lowering the minimum class numbers to 5 is a joke. We need to make the championship attractive to the mid to rear of field guys to enter. At the present entry cost there is no way that the mid field guys will enter just to get an experience of the nationals when they can compete at a club round on the same track for way less cost. The nationals need to be run by the clubs so that more competitors will be attracted to come and race at a national level by lower entry fees. It is time to take a few steps backwards before we can go forwards. If the nationals are given back to the clubs to run the numbers and the numbers have increased back to a respectable level then it can be re-assessed as to the suitability. If it continues with the SKA there will not be nationals to go to in 2013 as I believe that quite a lot of drivers will not enter the SKA event.

At present the 250cc International class is seriously inconveniences by the time and financial necessity to combine all gear box classes into the same races. There has not been one race in recent history that this class has been able to race flag to flag without the major inconvenience of having to make allowance for and avoid slow moving poorly behaved drivers from the slower classes. Not only is this combined field practice unfair to the high end competitors who pay significant sums on money to compete but it is downright ridiculous and in total opposition to the event status etc that you talk of in previous questions. Further I believe the SKA is in total breach of any duty of care to all competitors for allowing classes with such massive speed and lap time differences to compete together. In closing I believe the Sport is only as strong as the midfield and back end competitors who make up the majority of our classes. They seem to be complaining loudly for the past 2 years about the excessive cost of Shannons and in the difficult economic times we all face now you would be mugs not to take serious notice. My belief is that we should make sensible exit plans from the Shannons events, leaving the door open for a possible return in the future, then organise one weekend where all classes join together for a national event.

Keeping competitors up to date of drivers entered into each class day by day on the lead up to closing dates, if class's are not up to ten for a championship title then competitors in that class should be informed that the class has not made its minimum entry and give a chose of weather to compete or pull out, there's no point traveling and spending money for no outcome due to lack of entries.

VSKC put on a 2 day meet in September 2012 (the Island challenge), I would like to see the oz titles modelled on that and if it means the champion is not recognised by CAMS then so be it.

As the President of the NSW club I have the luxury of understanding that race meetings don't just fall out of the sky. A lot of hard work has to go into them, and the key for NSW has been putting numbers on the track which equate to dollars for the promoter, and also making the process as easy for the promoter as possible. Having the knowledge of what has to happen I applaud SKA for their efforts in an environment that has been quite hostile towards them by the Southern States. I applaud SKA for this survey to gain feedback from the community. I think for success a few things have to happen. Improved dialogue with the State Clubs and this isn't all SKA's fault. Perhaps around October each year SKA could seek opinion from the clubs as to what the club members want. In improved dialogue on all's behalf the club members could see that there are reasons why things can happen, and also reasons why things can't happen. I'd also like to highlight that CAMS need to take a stand and actually support SKA rather than make deals around it. As an example, a slot to VIC/SA was made available for \$6000.00 recently where CAMS are fully aware that this meeting was advertised falsely as something it wasn't. The question I'd have is why do CAMS support such negativity?. A general race meeting, great, but supporting negativity should not be on. It would be nice if SKA were offered the same luxury. I hear lots of stories and see lots of emails in my position and I must say I can see why things are turning into mess in places, which is also an embarrassment to the efforts I and others have put into our successful NSW club. I can be looked up via CAMS and welcome anyone from CAMS who may wish to discuss these issues with me personally.

Better promotion of the events/superkarting before/during and after the event no advertising was in any main motorsport media within a prominent area that I saw. Write up in current kartoz magazine 2 months after the event just a repeat of SKA website this was OK but should be better.

For the Australian Superkart Championships to continue, the Superkart Clubs need to become stakeholders in the Events somehow and assist when locally run. Cams needs to relax the 10 entries in a class to 5.

The costs of entry are very minimal compared to travelling and motel costs. The two round system is great and if you cannot afford it go to Rotax Max. When the Australian economy gets to low levels like it is now it has an effect on anything to do with luxury items (motor racing) We will also face the troughs and peaks and should move forward to ensure the years to come under the current format keep working. Any variation from this could lead to destruction.

Given the state of the economy I feel shannons has ,cost wise, just gone above most superkarters as a two race meet format. Most problems in this sport are personal and not based on logic. I feel until all the old school hatred dies out we will always struggle. I have discussed at length with many superkarters over all the states and the lack of logic being used to arrive at any decision is not real high. I can see only one solution and that is a non Superkart aligned category manager. SKA do a great job but the south will never adopt it so unless Cams step in make a long term decision on which we all have to abide the use of an external group may be the only way to progress what should be a spectacular form of racing. It honestly does my head in trying to keep everyone happy. QLD is going great guns as a club so I'll just keep doing what we do best up here and focus on our club. Would be great to be back with the V8's at Willowbank or the GC.

I would suggest that for the sport to expand it needs to be placed in a more attractive marketing field. The Shannon's series does not seem to work, as this event model has been used for a few years there does not seem to be any impact on race entries and new members. I would suggest a new avenue needs to be looked at, V8 Supercars would be ideal if you could get the entry fees to a respectable figure. Pit garages are also very important as we should not be on dirt at any stage. TV is important so that team owners and drivers can market themselves. Ideally I would like longer races and a 3rd round so that it is fair for all each year with travel. E.g. Phillip Island, Vic. Eastern Creek, NSW. QLD Raceway, QLD.

Costs at the Shannons National Race Series out of control. SKA are only passing the event costs on to the entrant that they get charged. Getting charged \$150.00 for tent space in the pits is madness. \$525.00 (1 event) entry fee needs to be more like \$300.00. Superkarts need a high profile event to give the sport a boost again. CAMS don't want us to go to Bathurst so CAMS needs to assist in finding Superkarts another high profile event. CAMS licencing need to be looked at so more people can go to these Australian Superkart Championship events as possible. They are great events. Non Gearbox needs to be bought back into the Australian Superkart Championship but this will only work if the clubs assist otherwise they will boycott. The sport needs to have Australian Superkart Champions and with 1 event, they can't get to that level. Clinto Brown (SKA) is a great at doing the Category Managers job at the race meeting. Great people skills and they job is done right.

In 2006/7 The Australian Championships were run as three heats of 4 laps and one final of 5 laps. Pitting arrangements were in carports that flooded at the rear of the circuit at Phillip Island. This year 2012 at PI, we had three heats of 8 laps and a 10 lap final with pit lane garages. This example shows the vast improvement of our Championship. The Shannons relationship works well. Our Class still pays less than anyone else in the series.

Consider three one day events throughout the year (Sundays) at three different state tracks. This would reduce the track hire time and therefore reduce the cost to low budget teams. Practice day would be available but at the drivers discretion to enter. Theses state clubs would bid for the right to have the championships at their track by assisting in running the event and possible financial support.

Run IT IN CONJUCTION WITH ALL STATE'S, STATE ROUNDS WHICH ARE ALL READY BEING HELD.

To be relevant in the current climate the SKA has to go back to the way it was supposed to be set up, with one member from each State that has a CAMS Superkart Club being elected by the club. The Clubs can remove their member from the SKA and replace them if they feel they are not doing a proper job. The Clubs to have an equal share in SKA, with an independent Chairman with no vote.SKA to be more transparent. No member of the SKA to be a member of the NSA. The SKA can only work properly with the complete support of the Clubs.

It's a little hard to complete this survey after sitting on the sidelines for a few years, but I didn't have a problem with the fees involved. It cost's money to race, if I don't have the money I don't race, Simple. At

the moment tough time's mean people don't have as much money to spend. Superkarting from my point of view is supposed to be a feeder to other aspects of motorsport, yet it seems everybody involved wants a trophy rather than racing for the sake of good racing. My two cents......

I think that one of the biggest issue's [especially with the southern states] is a pure lack of communication, at the VSKC I attend every monthly meeting, but we no longer have an opportunity to speak to Anton, or a 'rep' to discuss current plans, have input, or bring ideas to the table. Which is why many of us get aggravated by the fact that we give money to the SKA and see no feedback to what worked, what didn't and why. On Top of that, many of us feel unable to voice opinion and get what we want for our money as we do not have a representative. I do not care if the SKA, VSKC, all clubs combined, NSA or whoever run the championship, however I'd love to be able to go to the monthly meeting, see the representative for that group of "National level competition" and hear the 'latest' and give him ideas/suggestions ECT.

This survey is a clear indication that ska has no idea what its members want. For starters next time you hold a championship, how about making sure that more of your so called company directors etc are present, that would be a good start.as most people pay entry fees through their business accounts tax invoices would be a good thing also. The other thing is keep us your customers better informed, by emails not everyone is into Facebook. The level of professionalism in your company is appalling. In my opinion paying the ska money in advance for the championship may be necessary but given the way you people conduct yourself is very scary to say the least
