1. EVENT TITLE, DATE & VENUE

The event shall be known as Round 7 of the 2016 Shannons Australian Motor Racing Nationals, hereinafter referred to as "the Meeting" and will be held from the 11th November until the 13th November 2016 at Sydney Motorsport Park, Ferrers Rd Eastern Creek, NSW.

2. EVENT ORGANISATION AND STATUS

The event shall be held under the provisions of the International Sporting Code of the Federation Internationale de l'automobile (FIA), the National Competition Rules (NCR) and Race Meeting Standing Regulations (RMSR) of the Confederation of Australian Motor Sport Ltd (CAMS), relevant Category Sporting and/or Technical regulations as approved and published by CAMS, these Supplementary Regulations, any Further Regulations issued by the Organisers, any Bulletins issued by the Stewards of the Meeting and any Driver Briefing Notes issued by the Clerk of the Course.

5. CIRCUIT DETAILS

2016 Super Karts

a. Length: 3.93kmb. Direction: anti-clockwise

c. Track Density: The maximum number of starters permitted in any race will be in accordance with

CAMS Track Licence.

6. ENTRY CONFIRMATION

Opening Date: Tuesday 3rd October 2016 Closing Date: Friday 4th November 2016

Entries must be received by the closing date above.

If the number of entries received exceeds the maximum number of competitors as per these regulations the organiser reserves the right to accept those entries which it deems suitable.

Entries may be refused in accordance with NCR 83 of the CAMS Manual of Motor Sport.

Entry fee per category will be as negotiated via Series Management. All entries are to be submitted as per agreements between each category and Series Management, using the Series Entry Form.

7. PRACTICE, QUALIFYING & RACING

The final version of the Schedule of events will be advised in the event Further Regulations. Race formats as per Championship/Series Sporting Regulations.

8. START PROCEDURES (in accord with Series Regulations, and unless otherwise directed).

The Non-championship rolling start procedure will commence with the 1 minute signal at Pit Exit before proceeding with the Rolling Start Formation Lap behind the Safety Car.

9 GARAGE AND PADDOCK ALLOCATION

Booking of garages and positioning of vehicles in the garages will be as arranged with series category managers.

10. LICENCES

Each Competitor must hold a CAMS Competition Licence unless they comply with (a) or (b) below. Each Driver must hold a minimum of a CAMS Provisional Circuit competition licence unless noted otherwise against a particular event or specified otherwise in the Sporting Regulations for the relevant Championship/Cup/Series/Trophy/etc or:

- (a) hold a MotorSport New Zealand competition licence and Tasman Visa valid for the event; or
- (b) hold a minimum of the highest grade National Licence issued by a foreign ASN together with an authorisation issued by that ASN for the event; Such Drivers and Competitors:
 - (i) will be ineligible to score points in any Championship/Cup/Series/Trophy/etc connected with the event; and
 - (ii) must receive an authorisation to compete from CAMS prior to the event;

The Organiser confirms that the circuit to be used for this event holds the necessary CAMS National Track licence for each of the events nominated in these Supplementary Regulations.

11. GENERAL

Protests must be lodged in accordance with Part XII of the NCR.

Fuel must comply with Schedule G of the CAMS Manual of Motor Sport and any specific requirement of category Sporting Regulations.

Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

The promoter reserves the right to cancel, abandon or postpone the event in accordance with NCR 59. Cars must be adequately muffled to comply with noise restrictions as specified in the RMSR.

12. ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

13. SCRUTINY AND ADMINISTRATION CHECKING

Scrutiny at this event will be undertaken under the CAMS Targeted Scrutiny process, and the Series Administrator will liaise with the Category Manager / representative to ensure this happens smoothly. The Secretary of the Meeting will liaise with the Series Manager to meet each Category Manager / representative to arrange administration checking. This includes entry paperwork, pit crew sign on and other administrative requirements.

14. MoTeC BEACON: 996

The Shannons Nationals MoTeC beacon will be placed at the start/finish line. The frequency is 996. The Shannons Nationals beacon will be positioned closest to the start/finish line and no other beacons/stands may be placed within 3 metres of this 'official' beacon.
